Letter of confirmation of complying fund status – Plum Superannuation Fund (Fund)

The Plum Superannuation Fund (ABN 20 339 905 340, SPIN PSN0100AU) is a resident, regulated superannuation fund. The Trustee of the Fund is PFS Nominees Pty Ltd (ABN 16 082 026 480, AFSL 243357, RSE L0002912 R1056945) and it has elected to be regulated under the Superannuation Industry (Supervision) Act 1993 (SIS Act). Both entities can be found on the online register maintained by the Australian Prudential Regulation Authority (APRA), which can be located at www.apra.gov.au.

This letter confirms that:

- The Fund is a complying and regulated fund within the meaning of the Superannuation Industry (Supervision) Act 1993 (Cwlth);
- The Fund, and PFS Nominees Pty Ltd, as corporate trustee of the Fund, are subject to the Superannuation Industry Supervision Act 1993 (Cwlth) and the Corporations Act 2001 (Cwlth) and are regulated by the Australian Prudential Regulation Authority (APRA) and the Australian Securities and Investments Commission (ASIC);
- The Trustee will ensure that the Fund continues to satisfy all legislative requirements and does not expect to receive a direction under Section 63 of the SIS Act; and
- The Fund is able to accept contributions made pursuant to the Superannuation Guarantee (Administration) Act 1992, transfers and rollovers from other complying superannuation arrangements and provides for full vesting and preservation of preserved amounts pursuant to the regulations under the SIS Act.

Payments can be made either by cheque or BPAY®.

- **By BPAY** – To make contributions via BPAY, simply obtain the relevant biller code for your contribution type and the BPAY reference number, then make the payment using your financial institution's internet or phone banking service. Please note: BPAY contribution payments can be made from debit accounts (savings or cheque) only, not by credit card.
